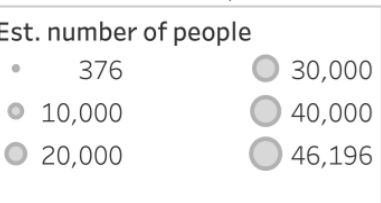

Headline Findings

- The average population for all blocks is 117 households or 497 individuals. 61 blocks have more than 1,000 residents, containing about 10% of the population.
- 83% of blocks say they need assistance with fuel. This is the most prevalent need identified in the NPM dataset. This is further corroborated by fuel having the highest average severity rating, after cash, coming before food, water or shelter.
- Shelter Assistance is also a pressing concern, with 52% of blocks requesting in-kind assistance and 23% of blocks requesting cash-based assistance.
- 910 blocks listed cash as their first priority, indicating that whilst many Rohingya face movement restrictions, many settlements are, nevertheless, integrated into local economies.

Indicator Explanations

- (A) The total number of individuals aggregated at the camp level; there are a total of 898,312 individuals.
- (B) The percentage of blocks which requested shelter assistance in Round 9; an estimated 657,000 people (73%) may require shelter assistance.
- (C) The percentage of blocks which requested for fuel in Round 9; an estimated 742,000 people (92%) may require fuel.
- (D) The proportion of block residents who do not have access to water, as estimated by the mahji; an estimated 342,000 people (37%) may not have access to water.
- (E) The proportion of block residents who do not have access to latrines, as estimated by the mahji; an estimated 294,000 people (33%) may lack access to latrines.
- (F) The percentage of block residents, estimated by the mahji, to eat two meals a day or less, this is estimated to be 322,000 people (36%).
- (G) The percentage of children who do not have access to non-formal education centres in Round 8; the proportion of the population who are children, according to UNHCR's family counting, was projected onto NPM population data to estimate the number of children affected. 97,000 children (20%) may lack access.
- (H) The estimated percentage of persons without access to the health services, including health facilities in the day and night, mobile clinics, vaccination, antenatal care, obstetric services, rehabilitation support, psychosocial care, mental health care; 325,000 people (36%) may lack access.
- (I) The percentage of blocks who do not communicate frequently with aid providers; 543,000 people (60%) may not communicate frequently.
- (J) The percentage of blocks where Rohingya face movement restrictions: they may face movement restrictions at checkpoints, whilst collecting firewood, and at markets; 536,000 people (60%) may face movement restrictions.

NPM Round 9 Summary Chart

This chart contains headline indicators broken down by Sector. This has been done to present a initial overview of the results whilst a more thorough report on Round 9 is developed. The NPM Site Assessment is a regular data collection and analysis exercise. For Round 9, more than 1,800 respondents (mostly mahjis) were interviewed. The total Rohingya population enumerated is 898,312. This summary includes 38 camps and excludes 15,844 people across 77 blocks out of 1,807, or 2% of the population, whose responses have been anonymised as they are predominantly small settlements in host communities and may be easily identified.

Responses have been aggregated here at camp level, meaning that the percentage depicted next to each point is the average for all blocks within that camp. The indicators depicted here are a mixture of Yes/No questions and mahji estimates. Blank cells indicate areas with insufficient data. The colour of each point is reflective of the relative severity of each indicator, with red being the worst. In the summary, camps have been sorted by their total population. The size of each point depicts the estimated population affected by each indicator; the specific indicator for the size is listed at the bottom of each column. The estimates for the affected populations for each sector indicator count each mahji's response as representative for their entire block; whilst mahjis are very aware of the types of services available in their areas, they do not have the fullest understanding of all issues – only 4 respondents were female.
